ECC - Code of Conduct

The ECC is a place where patrons can socialize in a comfortable environment that is drug, alcohol, and tobacco free. The Code of Conduct reflects this.

Eligibility

- All residents of Fairfield County are eligible to become members of the ECC through the purchase of a family, senior citizen, or individual membership.
- Family Membership encompasses all family members residing at the same primary address (household).
- The Facility Director or his/her appointed staff member may revoke eligibility at any time.

Rules

- Children, 13 and younger must be accompanied by an adult while visiting the ECC unless enrolled in an ECC program.
- Use, possession, sales or distribution of drugs, or drug elated paraphernalia is prohibited in the ECC.
- Alcohol may only be consumed in the ECC at a function sanctioned by management and in accordance with the ECC's Alcohol Policy.
- Smoking is prohibited inside the ECC facility.
- Inappropriate behavior, including but not limited to violence, threatening, weapon possession, explosive possession, dangerous actions, lewdness, stealing, vandalism, gambling are prohibited.
- The ECC is not responsible for the loss or damage of personal property.
- The ECC is not responsible for personal injury that results from reckless or irresponsible behavior.
- The onsite director or designated staff member in his or her absence has absolute authority to interpret the rules.
- Noise and loitering: Loitering and excessive noise outside of the ECC building and adjoining property is prohibited.
 Please consider our neighbors.

Procedures

- Members or their guests who are suspected of being under the influence of drugs and/or alcohol will be asked to leave the facility.
- If the situation warrants medical intervention, at the sole discretion of the ECC staff, the Easton EMS and Easton Police will be notified.
- Members or guests found in possession of drugs, explosives and/or weapons, or those that engage in other illegal activity, will be referred to police.

Suspension of Privileges

- Members or guests found to be in violation of the drug, alcohol, or inappropriate behavior rules will be removed from the ECC with up to a six-week suspension of privileges at the sole discretion of the Director.
- Repeated violations may result in a suspension of privileges or revocation. The length of such suspensions will be at the discretion of the Facility Director or designated staff member.
- A suspension or revocation may be appealed. Such an appeal will be review by a panel made up of the Facility Director and two members from the Board of Directors. The decision of the panel will be final.
- Members or guests found in violations of the weapons and explosives rules will be removed immediately from the ECC facility and will have their membership suspended indefinitely. Reinstatement may occur pending an appeal, a review by the above stated review panel and the consensus of the Board of Directors.

Access

- All eligible persons, wishing to become members, must complete the 'Membership Application' form and sign a pledge to adhere to the ECC 'Code of Conduct'.
- All members will be issued a bar coded 'Member ID Card' (Fob). Upon entering the ECC, each member is required to present and scan the card. It is also requested that they do the same on departure.

Automatic Renewal Agreement

This Automatic Renewal Agreement (the "Agreement") is a legally binding agreement between you ("Member" "you" or "your") and the Easton Community Center, Inc (ECC). This Agreement sets forth your rights and obligations with respect to the automatic renewal and payment of your annual ECC membership. By clicking the "I Agree" button, you are indicating that you have carefully read this Agreement, understand it, and consent to be bound by all its terms and conditions. If you do not agree to the terms of this Agreement, you should click the "I Do Not Agree" button and stop the registration process.

- I. <u>Terms, Fees and Payments.</u> Member will select a membership level and payment option during the registration process. Membership levels and terms are subject to change, without notice, at the sole discretion of ECC. The foregoing notwithstanding, fee for memberships already paid for will not change for the duration of the period for which payment has been received. By accepting, Member authorizes a payment to ECC from your credit card. Member authorizes automatic recurring payments for automatic renewal. Member understands that any automatic recurring payment method or renewal authorization will remain in effect until withdrawn by Member or terminated by Provider. Member must make all payments by VISA, MasterCard, or American Express.
- II. <u>No-Refund Policy</u>. All fees paid and charges made prior to Member's proper termination, including but not limited to any advance charge or payment for the membership term during which you terminate your membership is nonrefundable. Member's termination of membership shall not relieve you of any obligations to pay accrued fees.
- III. <u>Automatic Membership Renewal.</u> The renewed payment option will be the same as the payment option being renewed. At the time of renewal, ECC will charge your credit card the then-current fees for the applicable membership level and term. If Member selects automatic renewal option and fails to notify ECC of the decision to terminate your membership pursuant to Section II of this Agreement, your membership will automatically renew at the end of each term.
- IV. <u>Billing Date.</u> ECC shall charge Member's credit card on the "billing date," based on the Member's activation date and payment option. For the purposes of this Agreement, "activation date" is twelve (12) months from the current expiration date or date of registration or fourteen (14) months from current expiration date for auto-renew registrations. Member authorizes ECC to charge Member's credit card on the date of this registration pursuant to Section I.
- V. <u>Account Information</u>. Member agrees to provide true, accurate, and complete information about yourself and your billing information as prompted by the registration process. Member agrees to update any and all contact and billing information as it changes. ECC will not be liable for any losses, damages or interrupted access to ECC products and services caused by Member's failure to provide and update accurate contact and billing information.
 - A. <u>Termination.</u> Member may terminate your subscription at any time by providing ECC with thirty days' written notice. If Member violates this agreement, ECC may, in its sole discretion, with or without prior notice, terminate your membership.
 - B. <u>Limitation of Liability.</u> Member retains the entire risk arising out of use of ECC products and services, including the risks associated with entering this Agreement for automatic renewal and payment.
 - C. <u>Modification of This Agreement.</u> ECC may, in its sole discretion, modify this Agreement at any time with or without notice.
 - D. <u>Governing Law.</u> This Agreement shall be governed by and construed in accordance with the Connecticut law, without regard to or application of any choice of law or conflict of law's provisions.
 - E. <u>Merger Clause.</u> This Agreement constitutes the entire agreement between Member and ECC relating to the rights and obligations of Member and ECC regarding the subject matter herein. This Agreement supersedes all prior oral and written communications regarding the same subject matter.
 - F. <u>Severability Clause.</u> If a court of competent jurisdiction finds any provision of this Agreement invalid or unenforceable, such provision shall be severed from this Agreement, and the severed provision shall not affect any other provision of this Agreement.
